

## Linxiu Zhang

UNEP senior staff
Director, UNEP-International Ecosystem Management Partnership (UNEP-IEMP)

Dr. Linxiu Zhang, UNEP senior staff and Director, UNEP-International Ecosystem Management Partnership (UNEP-IEMP), a joint center between the Chinese Academy of Sciences (CAS) and UNEP. She is leading the implementation of a UNEP flagship programme focusing on the nexus of climate change, ecosystem services and sustainable livelihoods (CEL) through South-South cooperation. She is affiliated with the Institute of Geographic Sciences and Natural Resources Research of CAS as a senior research fellow and with the University of CAS (UCAS) as an adjunct professor. She is also a fellow of The World Academy of Sciences (TWAS). Prior to joining UNEP in 2018, she served as Director/Deputy Director of the Center for Chinese Agricultural Policy of CAS. She has more than 30 years of professional experience on policy-relevant studies on rural development, particularly in the fields of employment and migration, land tenure, public goods and services provision, poverty alleviation and sustainable livelihoods, climate change adaptation and gender.



# Pavan Sukhdev

Founder & CEO, GIST Impact

Pavan Sukhdev is a scientist by education, an international banker by training, and an environmental economist by passion. Years of work in sustainability and the invisible economics of nature led to his appointment to head the United Nations' "Green Economy Initiative" and to lead the G8+5 study TEEB (The Economics of Ecosystems and Biodiversity).

Pavan was awarded the McCluskey Fellowship (2011) by Yale University. At Yale, he taught a graduate course on TEEB and wrote his book "Corporation 2020-Transforming Business for Tomorrow's World". In this book, he advocates four changes in micro-policy and regulation

which can rapidly transform today's corporation to deliver tomorrow's green and equitable "economy of permanence". This led to his ongoing campaign (launched at Rio+20, 2012) on transforming business for tomorrow's world. Pavan promotes tomorrow's corporation, "Corporation 2020", one with positive rather than negative externalities as the engine of tomorrow's inclusive green economy.

As founder and CEO of GIST Impact, which delivers impact valuation and analytics, Pavan works with asset managers, C-suite executives and senior government officials on transition techniques, with anemphasis on metrics for sustainability.

Pavan has served on the boards of Conservation International (CI), the Global Reporting Initiative (GRI), the Stockholm Resilience Centre (SRC), and on the TEEB Advisory Board and has won several awards for his work including the Blue Planet Prize (2016) and the Tyler Prize (2020).

Michelle Guertin is the Head of Business Development and Resource Mobilization at ICIMOD – the International Centre for Integrated Mountain Development. She holds over 20 years of experience managing programs, projects, and multi-disciplinary teams in the public sphere (Government of Canada, including Global Affairs Canada, Environment and Climate Change Canada, and the Canadian Wildlife Service) and at the international level (CIMMYT-CGIAR and ICIMOD). She has played a key role in policy and regulatory development for biodiversity conservation in Canada, as well as in negotiations of international environmental agreements. Her experience lies in resource mobilization, strategic partnerships, and development cooperation in Africa, Asia, the Middle East and North Africa, and Latin America. Dr. Mathur obtained his doctorate degree from the University of Oxford, United Kingdom in1991. He has been the Regional Vice-Chair of the IUCN-World Commission on Protected Areas (WCPA-South Asia) from 2011-2021.

Dr. Mathur has been actively contributing on biodiversity research-policy interface issues and has been the Regional Vice-Chair (Asia-Pacific Region) of United Nations Intergovernmental Platform on Biodiversity and Ecosystem Services (UN-IPBES) Multi-disciplinary Expert Panel (MEP) (2014-2018). He is currently the UN IPBES Bureau member (2019-2023) and also the UN-CBD Bureau Member (2019-2022). In July, 2022 he was elected as the Vice-Chair of IPBES Bureau. His area of interest include Biodiversity Mainstreaming, International Biodiversity Negotiations and Green Infrastructure Development.



Weidong Zhou
